We offer workshops & training to equip SMEs to be ethical. We help them set up processes & procedures to prevent risk of slavery in their supply chains. 





Solar panel industry Uyghur forced labour links:

- 95% of solar panels globally rely on one primary material solar-grade polysilicon.
- The Uyghur Region accounts for approximately 45% of the world's solar-grade polysilicon supply.
- All four of the Uyghur Region's polysilicon manufacturers are implicated in Uyghur forced labour either through direct participation in forced labour schemes, and/or through their raw material sourcing.
- The four largest solar panel suppliers in the world all source from at least one of these polysilicon manufacturers.


SLAVERY IN AUSTRALIA

Number of Referrals and Victims Supported by the STPP



• Since 2014, the number of cases referred to the AFP and the Support Program has more than doubled.

STPP Clients by Type of Crime



- There is a continuing rise in victims of criminal forms of labour exploitation and forced marriage, which are the most common referrals to the Support Program.
- Victims of sexual exploitation are declining as a proportion of total victims on the Support Program.




